IMPORTANT INFORMATION

WARNING OF RISK

Recreational activities are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of injury when participating in any recreational activity/program. Understandably, not all hazards and dangers can be foreseen.
